As a "Public Officer" you must file a Financial Disclosure report. 29 Del. C. §5812(n). Reports are due between January 1st and March 15th of every year or within 14 days of appointment to the position, if the appointment occurs after March 15th.

In order to become a registered user of Delaware.gov you will need to create an account. Please provide the following information to create a Delaware.gov user account.
